

Kernersville Chamber of Commerce Tuesday Evening Golf League 2010 Registration

Registration deadline is Tuesday, April 27th

- The golf league will be accepting 24 players and an unlimited number of substitutes. Players will be accepted on a first-come, first-served basis, prioritized by last year's players and substitutes followed by new applications.
- All players must be a Kernersville Chamber member, or work for a company that is a Kernersville Chamber member.
- League opening play will be on May 4th, and will continue through June 22nd. All play will be on Tuesday evenings. If a player cannot participate on a particular Tuesday evening, then they must arrange for a substitute from our approved substitute list.
- League play will begin with between 5:30pm and 6:00pm, from the #1 Tee at Pine Knolls Golf Club.
- We will play 9 holes per league night.
- Teams will be determined by a blind draw, playing an A, B, C, and D level player on each team. We are not intentionally placing any players together of the same team.
- League scoring uses only handicaps from prior league play.
- Prizes awarded every week!
- Free Opening Night golf clinic for beginners prior to the 5:30pm start.
- All substitutes are welcome to play each league night, even if not participating in regulation play.
- The purpose of the league is networking and fun.
- The full set of rules and schedule will be sent out once registration is complete.
